Over the years, IPTSE has emerged as a strong national platform for IP awareness and capacity-building. The 8th edition received an overwhelming response by receiving approximately 60,000 sign-ups and 35,000 exam registrations. IPTSE today has signed 80+ MoUs with educational institutions across India. Its outreach is further strengthened through 300+ educational videos, on YouTube, 400+ awareness programmes, and around 1,000 IP-focused digital content across social media platforms

This year marking the 8th anniversary (edition) of IPTSE, IPTSE Awards & IP Conclave was held on 7 January 2026 at the India International Centre, New Delhi. The conclave brought together policymakers, industry leaders, academicians, IP professionals, creators, and students to deliberate on the theme “IP for Sharing – Promoting Collaborative Innovation”.

The conclave featured two thought-provoking panel discussions on collaborative innovation through IP and protecting creativity in the digital age, addressing open innovation models, licensing frameworks, copyright challenges, and fair remuneration for creators in the era of digital platforms and AI.

The event culminated with the IPTSE Awards Ceremony, recognising outstanding students, faculty members, professionals, and startups for excellence in IP knowledge and application. The 8th Edition reaffirmed IPTSE's sustained commitment to nurturing future-ready IP talent and positioning Intellectual Property as a dynamic tool for innovation, collaboration, and inclusive economic growth.

As IPTSE moves forward, it remains committed to strengthening engagement with students, professionals, institutions, and industry to nurture innovation and creativity through effective IP systems.

◆ 8th Edition Highlights



Launched in August 2025 with registrations closing October 20, the national-level exams ran November 19-22, 2025, drawing thousands of students, faculty, professionals, and startups across engineering, law, design, research, and more. Participants faced 60-question online tests on patents, trademarks, copyrights, and trade secrets, requiring 40% to qualify, with rankings based on scores, speed, and engagement—pushing cumulative registrations past 50,000 since 2018.

Pre-exam mock tests and sensitization webinars by experts like Dr. Sheetal Chopra and Nimesh Patel provided career-focused IPR guidance.

GUJCOST & CED Gujarat: Key Supporters of IPTSE

Both organizations bolster IPTSE's ecosystem, particularly in Gujarat, through sensitization events, training, and collaborative initiatives that enhance IP knowledge and practical application nationwide.



◆ 8th IPTSE Awards & IP Conclave 2026:

IP for Sharing, Promoting Collaborative Innovation

IPTSE successfully hosted the 8th IPTSE Awards & IP Conclave 2026 in New Delhi, bringing together over 200 participants from MSMEs, exporters, law firms, manufacturing and healthcare companies, startups, educational institutes, students, and government entities. Centred on the theme “IP for Sharing – Promoting Collaborative Innovation”, the conclave highlighted how robust IP frameworks can drive economic growth, enable collaborative models, and protect creativity in an increasingly digital and interconnected world.

The Inaugural Session featured Mr. Patrick Hofkens (Head of IPR Policy, Ericsson), Dr. G.R. Raghavender (Senior Consultant, IPR, DPIIT), and IPTSE Directors Ms. Hitaishi Trivedi and Ms. Purvi Pandya, who emphasized IP as a legal tool for innovation, the importance of India’s National IPR Policy 2016, and the need to balance sharing with fair rewards for creators.

Chief Guest Shri Aman Sharma (IPOS Joint Secretary, Department of Pharmaceuticals, Ministry of Chemicals & Fertilisers, Government of India) underlined India’s strength in generic pharmaceuticals, the emerging shift towards biologics, and the need to de-risk high-end R&D to build a stronger domestic IP-driven pharma ecosystem.



◆ 8th IPTSE Awards & IP Conclave 2026:

IP for Sharing, Promoting Collaborative Innovation

Two high-impact panel discussions explored “IP for Sharing – Encouraging Collaborative Innovation through IP” and “IP for Protecting Creativity in the Digital Age,” with experts from CSIR, Gujarat Fluorochemicals, SRF Limited, Jindal Global Law School, AAFT, Indian Performing Rights Society, and the music industry. Discussions covered industry-academia collaborations, standard-essential patents, fast-track commercialization initiatives, copyright and royalties in the age of AI, and the evolving rights of creators and performing artists.

The Awards Ceremony celebrated top-performing students, faculty, professionals, and startups from the 8th Edition IPTSE examination, recognizing their creativity and IP acumen in line with IPTSE’s mission to build an ecosystem where 10 million individuals understand and actively engage with intellectual property. Complementing the conclave, IPTSE also conducted a series of thematic workshops in November 2025 on prior art, pharmaceutical IP, economic analysis of IP, generative AI and legislation, data protection, and industrial application of IP laws, further strengthening IP capacity across the country.


